TUITION POLICY

Worldmind is a non-profit organization dependent upon tuition for funding to retain highly qualified, passionate staff and to cover operating expenses. Our preschool and kindergarten payment policy is that we will bill monthly with payments due on the second Sunday of each month. We need 60 days notice starting on the second Sunday of the month for any withdrawals. Families are responsible for payment during those 60 days. The 60 days will not start until the following month if submitted after the second Sunday of the month. Withdrawal requests must be submitted in writing and emailed to the Executive Director.
